## Update on Gilboa Dam Renovations

As many of you know, friends of Esopus Creek have been concerned about a significant threat to it since DEP released its planned renovations to the Gilboa Dam last April. The dam lacks a functioning downstream release mechanism, which is a serious safety concern. But the planned renovations include only a cold-water release mechanism. The Schoharie is a small reservoir. This means that in some years the Schoharie's supply of cold water could be depleted early. And in the case of an early season tropical storm, the cold water reserves could be dumped downstream to clear space in the reservoir for flood waters. This would force DEP to pump warm water through the Portal, which would have a devastating effect on trout in the Esopus.

Everyone recognizes that fixing the downstream release on the Gilboa Dam is an important safety issue. What's concerning is that DEP did not include a mechanism for a warm-water release in its original plans. However, DEP and DEC (which oversees dam safety) has heard the concerns of conservationists. Plans to install a warm-water release mechanism are now under consideration. In a March 2<sup>nd</sup> email, DEP Commissioner Emily Lloyd wrote to me:

"DEP fully understands the ecological and economic importance of the Esopus Creek. We will continue to do our best to balance water supply, ecology, recreation, public safety and other important interests that sometimes compete. We are hopeful that the additional release mechanisms being designed now will address many of the concerns you shared."



Once again, this is another example of the important role Trout Unlimited plays in protecting the cold-water fisheries we love. The Catskill Mountains Chapter, the Ashokan-Pepacton Chapter, and the New York State Council raised concerns about this issue early and kept demanding answers.

At this point, I'm cautiously optimistic that we will be able to avert a dangerous threat to the Esopus Creek. DEP has heard us, and now it's just a question of money. If New York City or New York State will provide the funds to install the warm-water release mechanism, then we will have a safe Gilboa Dam and a secure cold-water fishery in the Esopus Creek.

Because it's a question of money, though, it is important that we keep on top of things. If you want to help, send a note to Commissioner of DEP Emily Lloyd (ELloyd@dep.nyc.gov) and Governor Andrew Cuomo (<https://www.governor.ny.gov/contact>) letting them know your concerns and urging them to support the addition of the warm-water release mechanism to the Gilboa Dam renovations.

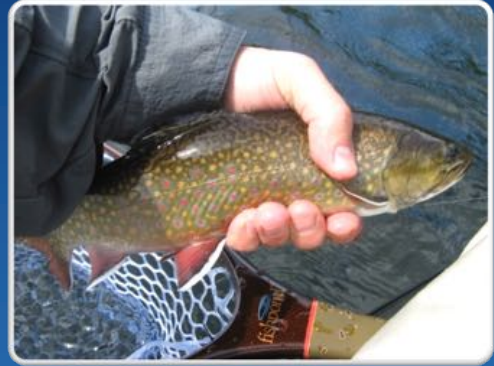
