## Thank You!! Stony Clove Creek Tree Planting

April 22<sup>nd,</sup> 2017

In collaboration with the Ashokan Watershed Stream Management Program (AWSMP), Ulster County Soil and Water Conservation District, the Catskill Mountains Chapter of Trout Unlimited organized a tree planting project along Stony Clove Creek, a major Esopus Creek tributary on Earth Day on April 22nd.

Stony Clove was traditionally a source of natural turbidity until some recent, major stream restoration projects.

AWSMP has been conducting a multiyear project to halt bank erosion on the Stony Clove Creek <u>http://ashokanstreams.org/awsmp-repairs-damage-on-</u> <u>stony-clove-creek</u>/

Thirty folks of all ages turned out to help in this project and in less than two hours planted more than 700 trees.

#### Esopus Creek Law Suit News

In the March newsletter, I told you that our 20-year effort to protect Esopus Creek suffered a serious setback when the US Second Court of Appeals upheld the Water Transfers Rule, overturning Trout Unlimited's earlier victory. As I explain in that article, the SPDES Permit, which governs New York DEP's discharges into Esopus Creek via the portal, are based on this. Now that the Water Transfers Rule is back in place, there's some uncertainty about the SPDES Permit and the future of Esopus Creek. There are fears that DEP could go back to treating Esopus Creek like a drainage ditch rather than a wild trout stream.

For these reasons, I urge you to come out to our May meeting and hear what DEC Region 3 Fisheries Manager Mike Flaherty has to say about the SPDES Permit and the future of Esopus Creek.

#### Watch out for Ticks

The season has just started, but anglers are already reporting a high number of ticks. The mild weather over the past two winters seems to have lead to an explosion of these pests. As we all know, many ticks in this area carry Lyme disease—and many other diseases—and while there are Lyme vaccines for dogs on the market, there are no vaccines available for humans. So take extra precautions as you head out fishing. Rather than offering advice about how to prevent tick bites, I'll point you to this page from the New York State Department of Health:

#### **Stand Up For Trout**

It's May and the fishing is starting to heat up. Just last week the Hendrickson hatch on the Delaware was going gangbusters. Given the season, I'd like to be writing this column about fishing. Better yet, I'd rather be fishing! But I can't write about that now because this is a perilous time for coldwater fisheries in the United States. The current administration in Washington has proposed drastic funding cuts and rule changes that could undermine longstanding bipartisan environmental protections that we've taken for granted over the past 20 years. The proposed federal budget slashes funds for the EPA by 31%! The Pebble Mine, a proposed open pit metal mine in the pristine Bristol Bay area of Alaska, home to some of the world's greatest salmon runs, is being revived after TU and other conservation organizations thought they'd stopped it. Public lands, which hold some of our nation's most important trout streams, are in danger of being turned over to states which don't have the resources to protect and manage them.

These aren't partisan issues. I know that we have members from all across the political spectrum, and that's important. That's one of the reasons why I'm proud to be a member of TU. No matter what our political leanings, we come together to conserve, protect, and restore North America's coldwater fisheries. Given the drastic threats those fisheries are facing now, it's more important than ever to let your voice be heard.

Of course, it's easy to say that. But if you're like me, you've got work and family responsibilities. You've got bills to pay and housework to do. It's hard to keep up with all the issues swirling around, much less to find time to take action. And let's face it, we're all a little burned out on politics after this past election.

Trout Unlimited recognizes this, so they've set up a special page to help us all keep track of the biggest threats to cold, clean water. Go to <u>standup.tu.org</u> and you'll find information on the major issues that TU is engaged in,



along with action alerts and easy ways to share your thoughts with elected officials.
